THESE ANIMALS ARE PROVIDED FOOD, WATER, AND SOCIALIZATION IN A 25,000 SQUARE FOOT FACILITY RUN BY A FULL TIME STAFF SEVEN DAYS A WEEK. THESE DOGS AND CATS ARE MADE AVAILABLE FOR ADOPTION TO THE PUBLIC SEVEN DAYS A WEEK FOR A NOMINAL FEE. ON OCCASION, SOME OF THE ANIMALS ARE TRANSPORTED TO RECEIVING SHELTERS IN THE NORTH OR ON TO BREED SPECIFIC RESCUES. THIS ORGANIZATION DOES NOT EUTHANIZE ANIMALS FOR LACK OF SPACE NOR PLACE TIME LIMITS ON ANIMALS AVAILABLE FOR ADOPTION.

ALL SPAYS AND NEUTERS, ROUTINE SURGERIES, DISEASE TREATMENT, VACCINATIONS, WELLNESS EXAMS, ETC. ARE PERFORMED BY THIS TEAM. COMPLEX SURGERIES AND SERIOUS ILLNESS REQUIRING SPECIALISTS ARE SENT TO PARTNERING VETERINARIANS WHO OFFER DISCOUNTED SERVICES.
